4. a) As you read **V4a**, has the widow been heard? Explain.  
b) In what situation have you literally been heard, but don't feel like you've truly been "heard"?
5. What finally caused the judge to grant her justice in **V4b-5**?
6. What are some possible reasons she was so persistent?

7. From **V1-8**, use your own words as you compare the attributes and attitudes of:

15. Why do you think she was willing to put in so much? Do you think she wrestled with the decision?

16. List some reasons people today are willing to give of their money, time, or skills at great cost to themselves?

17. a) Recount a time when you gave what did not make sense by the world's standards, but you knew that God had nudged you to do it? What blessings did you see?

b) In what situation is He inviting you to give sacrificially of your financial resources today?

18. What "good" lessons do you learn from these two widows who many would say were in "bad or ugly" situations?
